Tour Conditions and Pricing: This tour requires a minimum of 12 travelers to operate, and HMS reserves the right to cancel by July 8, 2007, with no liability. The tour price of \$4,425 per person is based on two to a room (\$475 supplement for a single room). A \$500 per person deposit is required to hold a reservation. Final payment must be received by July 8, 2007, or space is released and the cancellation penalty applied.

Refunds: A full refund minus a \$250 per person service fee will be provided if written cancellation is received between the date of booking and July 8, 2007. No refunds will be made for cancellations received after July 8, 2007. There will be no refunds for any unused portion of the tour.

Changes: For any name changes after final payment is made, a \$50 per person service fee applies.

Notice: All changes, cancellations, refunds or requests must be made in writing. Tour rates are based on conditions in effect as of October 2007; changes in fuel rates or surcharges may result in changes to the tour price.

RESPONSIBILITY STATEMENT AND LIABILITY DISCLAIMER

The L. Martin Travel Enterprises, HMS Travel Group (referred hereafter as The Company) directly manages a number of the tours offered; some tours, however, are managed by professional tour operators hired as independent contractors. The Company is acting agent for restaurants, sightseeing tour and transportation companies. As such, The Company cannot be held responsible or liable for any injury, loss, damage or delay arising out of, or in connection with any act, omission, neglect, accident, error or default of any such persons providing these services. The Company can also not be held responsible for any alteration of the group's itinerary, if such alterations become advisable or necessary for the safety and/or well being of the passenger(s). The Company cannot be held responsible for costs or other liabilities associated with any act of terrorism, war, accident, weather or any act of God. The Company reserves the right to refuse, accept or retain any person as a member of the group. If offered facilities or services become unavailable for reasons beyond our control, we reserve the right to substitute comparable facilities or services as available. By joining this group, the traveler accepts these terms and the noted terms of the program cancellation penalties.

Disputes: Any dispute arising out of the contract, catalogs, or other literature concerning the trip, or the trip itself, shall be resolved by Mediation with an agreed neutral. If the Mediation is unsuccessful, the dispute will be tendered to binding Arbitration under the provisions of the American Arbitration Association. Venue for both proceedings is in Sonoma County, California.
